Re: Active Status of Metropolitan Jonah

Dear Fr. Jillions:

As you know, I serve as ecclesiastical and civil counsel to His Beatitude +Jonah. We received an inquiry yesterday as to His Beatitude's status as and Archbishop, specifically as to whether he had "retired". There apparently has been some considerable confusion caused by various changes to the OCA website over the last several weeks with regard to whether His Beatitude has retired or remains an OCA Archbishop. Indeed, at one point, His Beatitude was dropped from the episcopal list, subsequently was restored and now, erroneously, appears on the retired list. See <http://oca.org/holy-synod/retired>

While His Beatitude stepped aside in July as Primate, he has not in any way "retired and remains" an active Archbishop in the OCA. As websites frequently are maintained by individuals unfamiliar with ecclesiastical matters, I am sure that this is simply an oversight.

However, given the increasing confusion amongst clergy, laity and the general public, I must ask you, in your capacity as Chancellor of the OCA, for an immediate correction to the website and all other clergy lists to accurately reflect His Beatitude's status as an active Archbishop and member of the Synod.
